

## **Darwin International Airport: Competition Terms and Conditions**

## **Terms & Conditions**

- **1.** Information on how to enter and prize details form part of these terms & conditions (Terms of entry). The Terms must be read in conjunction with the Schedule. The Schedule defines the terminology used in these Terms of entry. If there's any inconsistency between these Terms and the Schedule, the Schedule prevails. Participation in this Promotion signifies acceptance of these Terms of entry.
- **2.** Entry is open only to legal residents of the Eligible States/Territories who meet the Method of entry. Directors, officers, management, employees, suppliers (including prize suppliers) and contractors, and their immediate families of the Promoter, its related bodies corporate, agencies, and companies associated with this Promotion, including TPAL (Trade Promotions and Lotteries Pty Ltd), cannot participate. Immediate family includes the following: spouse, ex-spouse, child, step-child, parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister, or first cousin.
- **3.** The Promotion runs during the Promotion period.
- **4.** Any stated time relates to where the Promoter is based, unless stated otherwise.
- **5.** Prizes are specified in the "Details of prizes" section of the Schedule.
- **6.** Total prize pool is in the "Total prize value" section of the Schedule.
- **7.** Unless mentioned otherwise, prizes are valued in Australian dollars.
- **8.** Prizes involving travel must align with dates in "Details of prizes" section or conditions of third-party travel provider. Any change in confirmed prize details will be at the winner's expense and only with prior approval of the Promoter or third-party travel provider.
- **9.** Travel prizes, unless specified, don't include: travel insurance, travel documents, meals, taxes outside of ticket price, transfers, flights, accommodations, or personal costs. Winners must comply with all travel requirements. Non-compliance may lead to prize forfeiture. Promoter doesn't guarantee safety or other conditions during travel or at destinations.
- **10.** Prize travel depends on availability when booking. Winners and companions, if applicable, must travel together. The Promoter isn't responsible for cancellations, delays, or rescheduling and any related costs.
- **11.** Event prize winners must confirm availability for specified dates. If not, they may be deemed invalid. Promoter may redraw to award the prize, as per any relevant authority directions.
- **12.** Neither the Promoter nor associated companies or agencies accept responsibility for any Event delays or cancellations.
- **13.** If any Event part is altered or postponed, winner may forfeit rights to attend. No compensation will be given for these changes.
- **14.** Entrants must adhere to any conditions accompanying the Event.
- **15.** Vouchers are valid until the expiry date provided.
- **16.** Entrants must follow conditions accompanying the Voucher.

- **17.** The Promoter and voucher provider aren't responsible for stolen, forged, lost, damaged, or tampered vouchers.
- **18.** Entrants should consider tax implications of prize winnings and seek independent financial advice. The Promoter isn't responsible for tax implications. Entrants handle all expenses for entering the competition without reimbursement.
- **19.** Entrants must follow the Method of entry during the Promotion period. Failure results in invalid entry. Invalid entries won't be notified by the Promoter.
- **20.** The time of entry is when the Promoter receives it.
- **21.** Entrants can submit up to the Maximum number of entries.
- **22.** The Promoter isn't responsible for late, lost, delayed, incomplete, corrupted, illegible, or misdirected entries or claims. No liability is accepted for user error, omission, tampering, or theft. No correspondence will be entered.
- **23.** Prizes will be awarded to valid entrants drawn as per Prize draw details. If a draw is on a public holiday, it might be held on the next business day. The Promoter might draw additional reserve entries. If a prize isn't awarded to an entrant drawn, the process continues until a winner is determined.
- **24.** Winners don't need to be present at the draw unless stated.
- **25.** Winners will be notified per the Notification of winners and Notification of unclaimed prize winners sections of the Schedule.
- **26.** The Promoter isn't responsible for contacting winners with incorrect or incomplete details. If details change during the promotion, it's the entrant's duty to inform the Promoter.
- **27.** Accepting a prize means the winner agrees to all conditions of the prize and the prize supplier's requirements.
- **28.** The winner's name and state/territory will be published as per the "Public announcement of winners" section of the Schedule.
- **29.** Unclaimed prizes might be redrawn. If so, new winners will be contacted and published as per the Schedule. If a prize isn't available, the Promoter can substitute for a similar prize of equal or greater value, subject to approval of state authorities.
- **30.** Promoter's decision is final. No correspondence will be entered.
- **31.** Entrants and participants in the promotion acknowledge that the Promotion isn't sponsored, endorsed, or administered by any third party unless specified.
