Contractor Parking Terms & Conditions

PARKING AREAS AND USE

- 1. On approval of this application, the user may park in the designated contractor bays as listed on the application or as specified by us.
- 2. Parking is only permitted for the duration of works being carried out on DIA property.
- 3. The use of the contractor parking for personal reasons, or overnight parking is not permitted, and DIA may, at any time cancel access privileges if cards are used inappropriately or not in accordance with these Terms and Conditions.
- We reserve the right to alter the location of allocated 4. bays from time to time.
- 5. You must comply with:
 - all applicable Northern Territory and a. Commonwealth laws
 - all signs and directions contained in the car parks b.
 - c. all reasonable directions and requests made by us from time to time.
- You must not obstruct any or other vehicles or car park 6. bays, or access to them.
- 7. If you are towing a trailer or have a large vehicle please contact the parking team at parking@darwinairport.com.au to make appropriate arrangements.
- 8. Failure to comply with these conditions may result in the issue of a parking infringement notice and the vehicle owner or driver will be liable to pay penalties and associated parking fee's at Short Stay rates.

ACCESS CARDS

- 7. Entry into the Car Park is permitted only to holders of a valid Access Card.
- 8. The initial access card is Free of Charge, lost or damage cards will incur a \$35.00 inc GST replacement fee.
- 9. We may, at our discretion, cancel an Access Card and deny use at any time if:
 - the Car Park is rendered unfit for use due to a. circumstances beyond our control
 - you are in default of any of these Terms and h. Conditions.
 - there has been a period greater than 6 months c. without use.

INDEMNITY

- 10. You drive, park and leave your vehicle at your own risk and you remain responsible for your vehicle and any property in or on it.
- 11. We are not liable, except to the extent required by law, for:
 - any theft, loss, or damage whatsoever to any а. vehicle, its accessories, or its contents
 - any death or injury of any person b. while you, your vehicle or your property are in the Car Park or while you are entering or leaving the Car Park.
- 12. We may, at your expense, move or remove your vehicle if, in our opinion, it is parked in an unauthorised or unsafe position, is unregistered or appears to be abandoned, and if we move your vehicle, these conditions continue to apply.
- 13. We reserve the right to retain your vehicle, and all goods in or attached to the vehicle, as security for any money which you owe us under these terms and conditions. If you fail to pay any money you owe us, we may sell your vehicle in accordance with all applicable legislation.
- 14. Failure to comply with these conditions may result in the issue of a Parking Infringement Notice and you will be liable for the payment of penalties.

SECURITY

- 15. You must strictly comply with all directions of DIA in relation to safety and security issued from time to time.
- 16. The use of our car parks is governed by the Conditions of Use. You agree to be bound by and comply with the Conditions of Use as amended and published by us from time to time.

- In these conditions references to: a. "we", "us" and "our" mean Darwin International Airport Pty Limited ABN 87 081 258 157, its employees, agents, and independent contractors;
- "you" means the person using, or intending to use the car park; and "your vehicle" includes a vehicle driven, or intended to be driven, by you into the b. Permit parking facilities.
